ORDER

WHEREAS Dakshin Bharat Hindi Prachar Sabha(DBHPS), Rajeev Gandhi B.Ed College, Dharwad, Karnataka applied for recognition for conducting B.Ed course to the Southern Regional Committee, (National Council for Teacher Education), Bangalore on the 15th February, 1999.

AND WHEREAS the Southern Regional Committee, (National Council for Teacher Education), Bangalore in its Order No. F-SRO/NCIE/1999-2000/DBHPS-EXI/7988 dated the 5th May, 1999 (hereinafter referred to as the Order) refused recognition to DBHPS Rajeev Gandhi B.Ed College, Dharwad for conducting B.Ed course for the reasons stated therein.

AND WHEREAS the Registrar, DBHPS, T. Nagar, Chennai and the Principal, DBHPS Rajeev Gandhi B.Ed College,Dharwad (hereinafter referred to as the Appellants) appealed to the National Council for Teacher Education, New Delhi (hereinafter referred to as the Council) on the 10th June, 1999 under the provisions of Section 10 of the National Council for Teacher Education Act, 1993 against the said Order refusing recognition.

AND WHEREAS Shri. M.L. Dakhani, Principal, DBHPS presented the case of the appellant institution in person on the 11th November, 1999. According to the report of the visiting team, which visited this institution on the 25th September, 1999, although accommodation is provided in the same campus where other courses are being conducted, it is adequate; there is one principal and six lecturers all M.A., M.Ed for an intake of 60; librarian and instructor in music are qualified; lecturer for physical education and instructor for work experience are part-time and adequate equipment, books and furniture are available. It is submitted in the appeal that teachers are being paid on pre-revised U.G.C. scales, only 5 out 17 practice teaching schools are out of station schools and a play field has been provided. The Secretary, DBHPS has given an undertaking to provide adequate funds as required under para 5.1 of the National Council for Teacher Education norms and standards for secondary teacher training institutions.

AND WHEREAS the Council after carefully considering all aspects of the matter has come to the conclusion that the appeal deserved to be accepted and the Order of the Southern Regional Committee, (National Council for Teacher Education), Bangalore dated the 5th May, 1999 refusing recognition reversed. As a consequence the Council hereby grants recognition provisionally to DBHPS

Rajeev Gandhi B.Ed College, Dharwad for conducting B.Ed course during the academic session 1999-2000 with an intake of 60 students. The institution should comply with the minimum number of working days prescribed in the norms and standards for the academic session 1999-2000. For recognition beyond 1999-2000 the institution should approach, Southern Regional Committee, (National Council for Teacher Education), Bangalore in due course.

AND NOW THEREFORE the Council hereby reverses the Order appealed against subject the condition stated above.

ORDER

In exercise of the powers vested under Section 14(3)(a) of the National Council For Teacher Education (NCTE) Act, 1993, the Southern Regional Committee grants recognition to Dakshin Bharat Hindi Prachar Sabha Rajiv Gandhi B.Ed College, B.C.Compound, Dharwad-580001, Karnataka for B.Ed Course of one year duration from the academic session 2000-2001 with an annual intake of 60 students, subject to the following conditions:

1. All such teachers already appointed who do not have qualifications as per NCTE norms shall acquire the qualifications as per the norms within a period of two years of this order.
2. The institution shall ensure library, laboratories and other instructional infrastructure as per the NCTE norms.
3. Technical Assistant should be appointed.
4. The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating University / State Government.
5. Tuition fee and other fees will be charged from the students as per the norms of the affiliating University / State Government till such time NCTE regulations in respect of fee structure come into force.
6. Curriculum transaction, including practical work / activities, should be organised as per the norms and standards for the course and the requirements of the affiliating University / examining body.
7. Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.
8. The institution, if situated, shall maintain endowment and reserve fund as per NCTE norms.
9. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The performance appraisal report should inter alia give the extent of compliance of the conditions indicated above.

If Dakshin Bharat Hindi Prachar Sabha Rajiv Gandhi B.Ed College, D.C.Compound, Dharwad-580001, Karnataka contravenes the provisions of the NCTE Act or the rules, regulations and orders made or issued thereunder or fails to fulfill the above conditions, the Regional Committee may withdraw this recognition under the provisions of Section 17(1) of the NCTE Act.
